ORDINANCE 2019-02
2020 MEETING SCHEDULE**

AN ORDINANCE OF THE LEEDS TOWN COUNCIL ESTABLISHING A TIME FOR REGULAR TOWN COUNCIL MEETINGS AND PLANNING COMMISSION MEETINGS

WHEREAS, the Town Council of the Town of Leeds has held a Town Council Meeting on the 11th day of December, 2019; and discussed the 2020 meeting schedules; and

WHEREAS, the Town Council approved the 2020 meeting calendar with 2 Town Council meetings a month (second and fourth Wednesdays) for 8 months (January, February, March, April, May, June, September, and October) and 1 Town Council meeting a month (second Wednesday) for 4 months (July, August, November and December), and to approve 1 Planning Commission meeting a month (first Wednesday) for 11 months (February thru December). Due to the New Year's holiday falling on the first Wednesday, there will be no Planning Commission meeting in January. Due to the Veteran's Day holiday, the November Town Council meeting will be held on the third Wednesday.

WHEREAS, the Town Council of the Town of Leeds understands the need to provide proper notice if any changes to this schedule become necessary.

NOW THEREFORE, BE IT ORDAINED BY THE TOWN COUNCIL OF THE TOWN OF LEEDS, UTAH, THAT THE FOLLOWING SHALL BE ADOPTED:


1. The Leeds Planning Commission will conduct Planning Commission Meetings at 7:00 PM in the Leeds Town Hall on the first Wednesday of the month for 11 months (February thru December). Due to the New Year's holiday falling on the first Wednesday, there will be no Planning Commission meeting in January. Meetings can be adjusted with proper notification and as allowed by law.
2. The Leeds Town Council will conduct Town Council Meetings at 7:00 PM in the Leeds Town Hall on the second and fourth Wednesday of each month for 8 months (January, February, March, April, May, June, September, October) and 1 Meeting a month (second Wednesday) for 4 months, (July, August, November and December). Due to the Veteran's Day holiday, the November Town Council meeting will be held on the third Wednesday. Meetings can be adjusted with proper notification and as allowed by law.
3. The Town Council will provide proper notice of any changes to this 2020 Town of Leeds Meeting Schedule.
4. This Ordinance shall become effective on December 11, 2019.
