Short-term Rentals

The matter of short-term rentals in the town of Leeds has been under review by the town's Planning Commission. Short-term rentals by definition is a residence rented for less than 30-days.

Short-term rentals have mixed reviews from residents and property owners in the areas effected. Some are concerned businesses will buy up housing for rental, reducing inventory long-term residents. Others have vocalized a property owner should have all rights to use their property as they wish.

Current town code allows for residents to rent 25% or less of

Recent Primary Elections in Washington County, Iron County, Kane County, disclosed critical concerns for election officials. Ballots mailed on or before the deadline were not postmarked for several days afterward, because the mail is processed in Las Vegas, Nevada and not at the post office where the ballot was This discovery mailed from. resulted in law suits from candidates, public angst, and questions about election integrity since the legislators knew the problem existed before the election.

You can still mail your ballots; however, be sure to mail it at least several days prior to the election deadline (Nov 4th). You can also drop off your ballot at Leeds Townhall or at the Washington County building.

Voter registration deadline is by 5PM October 25th.

Washington County has implemented a search program to identify residential homes listed on vacation rental websites and sends that information to municipalities to enforce TRT tax reporting.

Residents are encouraged to participate in planning commission and town council meetings to vocalize their positions, as an updated ordinance is drafted and codified, soon.

- Council votes majority must be met

Leeds Considers Joining Regional Water Supply Agreement

The Town of Leeds, in collaboration with the Washington County Water Conservancy District, is currently reviewing the possibility of joining the updated Regional Water Supply Agreement. This agreement builds on the original version signed by the town in 2017 and introduces key components such as water conservation measures and adherence to the Hansen, Allen, and Luce study. This study regulates the placement of septic systems in the region to protect water resources.

A significant aspect of the new agreement includes water reuse, which supports sustainable water practices for the town. In a recent meeting, the Leeds Town Council voted to submit a formal request to the board of the Washington County Water Conservancy to join the agreement.

If approved, this partnership will allow developments currently unable to receive water from the Leeds Domestic Water users Association (LDWA) to access water resources without needing to disconnect from the Town of Leeds.

Understanding the Truth in Taxation for Fire and EMS



Hurricane Valley Fire District services the fire and EMS needs of several municipalities; Hurricane, Laverkin, Toquerville, Virgin, Rockville, Springdale and Leeds. The department also covers all of the unincorporated county areas.

Fire and EMS calls have risen year over year, 2024 anticipated to exceed 6,500. About 80% of those calls are for EMS.

The District attempted a 89% tax increase to the portion of taxes each property owner contributes to Fire and EMS in 2022. This effort was ceased at the Board level.

The Board drafted legislation with the assistance of Representative Joseph Ellison, that enabled a percentage of sales taxes to be used for funding Fire and EMS. Since over 35% of calls are attributed to tourists, and tourism brings about 5 million people to the area, while only 35 thousand people reside in the District, placing some of the burden on tourists seemed fair.

The bill passed; however, some flaws revealed that were remedied the following legislative session. Unfortunately, that modified bill died at the Senate floor and was not voted upon. The District has received high confidence from legislators the bill will pass in 2025; however, the District does not want to risk the safety of our citizens. The property tax increase is only a safety gap, incase the sales tax somehow fails again. When the sales tax bill passes, property taxes will be reduced significantly - to below 2024 levels.

The proposed increase from 0.000699 to 0.001063 will be reviewed by the Board, after the public hearing with a decision proposed to the County Commissioners, following. The proposed tax increase will render the department approximately 2.3 million to sustain current levels of service, prevent closing any stations, and avoid laying off any personnel.

The department has experienced the damaging effects of inflation the country has experienced over the past 3 years - higher gas prices, insurance rates, equipment costs, and more.
