- 1. CALL TO ORDER: Mayor Melvin J. Evans called the meeting to order at 7:35 p.m.

- 3. PLEDGE: Mayor Evans.
- 4. APPROVAL OF AGENDA, FINANCIAL STATEMENT AND MINUTES:
  The agenda was approved. The financial statement and minutes were passed at this time. They will be approved at the next Council Meeting.
- 7. OTHER BUSINESS:

 At this time the Mayor asked if anyone in the audience needed to comment before they moved on with the night's business. Seth Larsen asked to speak.

Seth Larsen owns property at approximately 600 North Main Street. He would like to put a manufactured housing business on this property. He asked the Council if he could have someone live in one of the homes, which would be a permanent office/home. The tenant would be selling the Modular Homes and would like to live on the property.

The Mayor told Mr. Larsen that it would have to be referred to the Planning Commission to make a decision on whether or not it could be allowed. The Planning Commission would then bring the decision back to the Town Council.

\* Mr. Ralph Chandler, who is planning to buy property from Mr. Marell Walton, asked about a Conditional Use Permit for horses on the 3 acres that he plans to buy.

After much discussion on this topic and taking into consideration the neighbors surrounding the property in question the following motion and vote took place:

MOTION: Joanne Thornton made a motion to give Ralph Chandler a Conditional Use Permit based on our current ordinance so that he can go to escrow on the property in question. Charlie Scott seconded the motion. The vote passed with 4 in favor and 1 in opposition.

He will have a preliminary plan done in approximately 2 months. He also requested oil changes for the fire vehicles and an air intake for one of the engines. He also requested that he be allowed to start looking for a new engine for the brush truck.
