

Minutes of the Town Council
February 23, 2005

1. CALL TO ORDER:

Mayor Norma Gier called the meeting to order at 7:02 p.m.

2. ROLL CALL:

Present was Mayor Norma Gier, Council Members, Gloria Parnell, Dave Harbour, and Dale Barnes. Darrell Nelson was excused.

3. PLEDGE OF ALLEGIANCE:

4. APPROVE AGENDA AND MINUTES:

Mayor Gier noted several corrections to the January 26th meeting.

Motion by Dave Harbour to approve the agenda and minutes of January 26, 2005, as amended. Seconded by Gloria Parnell. Passed unanimously.

5. MAYOR NORMA GIER:

Discussion on the Transportation Enhancement Project. The Council discussed various aspects concerning the project. The pressurized irrigation system, curb and gutter, and Main Street beautification.

Follow up on Utah League training. The Council was pleased with the training on February 16th. The training was sponsored by the Utah League of Cities and Towns. One thing the Council wants to look into is a part-time planner for the town.

6. COUNCIL MEMBER DARRELL NELSON:
