# **Town Council Meeting Minutes**

February 27, 2013

#### 1. Call to order:

Angela Rohr, Mayor called to order the regular meeting of the Leeds Town Council at 7:12 pm on February 27, 2013 at Leeds Town Hall, 218 North Main.

#### 2. Roll Call:

The following persons were present: Mayor Rohr, Joe Allen, and Frank Lojko, who was participating via the Skype System from Salt Lake City, Utah.

- 3. Invocation was given by Mayor Rohr
- 4. Pledge of Allegiance by Joe Allen
- 5. Declaration of abstentions or conflicts: None
- 6. Approval of agenda:

Joe Allen "moved" to approve tonight's agenda and regular meeting minutes of February 13, 2013. Seconded by Mayor Rohr. All voted "Aye".

- 7. Announcements: Mayor Rohr thanked former Mayor Roberts for his many years of service and dedication to the town. She talked about new playground equipment that has been installed in the Park and how well-received it has been by the children of Leeds. She mentioned the possibility of scheduling speakers to talk about various subjects in future meetings. Mayor Rohr indicated that she had been called by a California businessman who is interested in re-locating his business to Leeds. The business is light manufacturing and would require a 20,000 sq. ft. facility and hire 10 people. The move would be dependent on adequate financing. She said that Darrell Nelson had been appointed to the Planning Commission and 2 other candidates were under consideration.

#### 9. Action items

Consider Silver Reef Foundation: Joe Allen began the discussion by explaining the scope and purpose of the Foundation. The group has been disappointed with the museum being closed and would like to see it re-open. He explained that the property, building and artifacts are owned by Washington County. Joe said their group met with the County Commissioners to consider the possibility of re-opening the museum under Foundation guidance and management. The Foundation corporation has not yet achieved its tax exempt status as a 501 ( c ) ( 3 ) corporation and in the interim would like the Town to collect the donations until the tax status is achieved and then remit the funds to the corporation. No action was taken by the Counsel.

#### 10. Discussion items:

- a. Princess Pageant Roxann Lewis: Roxann and her daughter, MC Cady spoke about the Pageant and the positive effects it has on the girls in the Pageant. Roxann discussed the budget needs of the Pageant. The current budget has \$750 allocated and Mayor Rohr said they would review the issue in at the next Council meeting in 2 weeks.
- b. Discuss formation of 3 person committee to finalize Codification: This committee would consist of 3 people to work with the Company working on the codification of the Town ordinances and resolutions. Mayor Rohr asked for volunteers to move this work forward as it has been 3 years in the process. Ron Cundick and Wayne Peterson volunteered to serve on the committee.
- c. Discuss formation of 3 person committee to finalize Zoning map: The purpose of this committee would be to update Zoning maps. Paul Densley and Ron Whitmore volunteered to serve. Mayor Rohr talked about reactivating several other committees such as Emergency Preparedness and Cultural and Beautification.
