Discuss Changes to Land Use Ordinance pursuant to SB174 a.

Mayor Hoster started the meeting explaining that we now have the proposed changes to the Land Use Ordinance in a format where we can see what has been added, changed, or deleted. He asked Scott Messel to walk us through the changes. He talked through the changes. There was some discussion about Grading Bonds. Mayor Hoster asked Councilmember Furley if he had anything to add about the Blasting Permit requirements. Councilmember Furley said he had read through that section a few months back and he thinks everything had been covered at that time, but he would get back to him. He spoke about the two separate subdivision processes, for STT or the Legacy Process. Questions were raised about the time restraint put on the town when an application is turned in. The concern is that 20 days is not enough time with the limited resources available at this time. After much deliberation, it was determined that the time limit is on the scheduling of the application, not on the actual meeting. Once the application is approved as a complete application, it must get "scheduled" with the approval committee within 15 days and then has to be "scheduled" for the next regularly scheduled Planning Commission Meeting within 20 days.

Discussion was had about how application submissions are handled. The Councilmembers would like to have submissions in an electronic format in addition to the hard copies. Councilmember Stirling wants to thank everyone involved in bringing this Ordinance to life. Councilmember Furley said he does not see anything in the Blasting section that needs to be changed. Mayor Hoster advised that a Motion to approve this Ordinance would be with the changes discussed in this Work Session.
