#### Mayor's Message

It's spring and water runoff is anticipated to be higher than normal this year. The town has been advised to warn residents to be prepared by ensuring floodplanes are kept clear. Some areas have been filled with dirt, rocks, and other debris, even on private property, which will cause serious damage during flooding and spring runoff.

Some have experienced new construction in their neighborhoods. The calls about fugitive dust, the noise from the excavation equipment, and change in scenery seems to understandably have many agitated. Change is inevitable, though. Those same things occurred when building your lovely home in Leeds. The town does not proactively seek out ordinance violations and attempts to respond to complaints with the limited resources available. Being a kind neighbor and having a discussion, patience, and acceptance can go along way.

#### Land, Growth & Changes

Leeds is known for our rural, agricultural landscapes, and solitude. Just like in every other location across the country with a similar setting, growth occurs.

Leeds jurisdiction has a great deal of land that is undeveloped, yet owned and intended for development. We also have remodeling, landscaping, and other construction projects changing things up a bit.

Change can happen to us, or with us. If we wish to have a seat at the table, we must identify ways to work with those exercising their property rights to build a more harmonious community. Unfortunately, we are not able to just shut the door behind us, after we moved to Leeds.



The lands owned by SITLA are located on the North and South sides of Silver Reef Dr. The land to the South is under contract, while the land to the North is intended to be opened within the next several years.

Silver Pointe Estates is the development located near the Christy Mine, at the East end of Silver Reef. This area has encountered environmental concerns and other delays; however, the town is working with the developers to ensure that everything remains safe to current and future residents.

Grapevine Wash is expected to turn dirt in 2024 with nearly 940 roof tops targeted, with some commercial, as well.

Construction is never enjoyable, but it was necessary for us all to move to Leeds. I hope we'll all practice being good neighbors, as Leeds grows.

Teenage drivers and late senior drivers share the same statistics. The three known causes are distractions, speed, and time of day (night is the worst). Teens are 99% less likely to have an accident with a parent in the vehicle.

#### HB 442 fails in the Senate, leaving Fire/EMS unfunded.

HB 442, a house bill drafted by Rep. Elison, proposing a sales tax option for funding fire and EMS in Washington County, in lieu of relying solely on property taxes, failed in the Senate, this last legislative session.

The sales tax proposal would mitigate the costs of fire and ems from residential property taxes to sales taxes associated with tourism. An estimated 5.5 million tourists visit Southern Utah annually.

The County and District are researching alternatives to making any cuts to the department and services.

The senate was successful in passing an \$81 million sales tax for funding a Major League Baseball stadium for Salt Lake City and the Larry H. Miller organization, leaving many residents wondering what is the true purpose of government?



#### **Zoning and SB174**

SB 174 was passed in the 2023 legislature, which essentially moves all land management from the legislative body to an appointed body in local government. The town plans to work with citizens in addressing zoning in undeveloped and then developed land, to ensure a smooth process for the appointed land authorities to remain consistent with the citizens of Leeds. SB174 will engage December '24.

## Leeds Park Receives Improvements





Leeds Park is a beautiful gathering place for all. The park has endured the test of time, but is due for some improvements. Our new Parks employee, Bill Stone, has been hard at work repairing the playground equipment. Volunteers came out to help spread new safety chips for the playground, improving the safety of the equipment's use and adding a little color. Parents are advised the new chips can "bleed" when wet, so please be selective in clothes your children wear, at first.

New playgroups have assembled to gather and enjoy the park's beauty, lately. This past winter; however, vandalism to one of the main slides occurred, costing tax payers several thousand dollars, and eliminating use of the slide. The damage could not effectively be repaired, resulting in the purchase of an entirely new slide.

The town will be placing cameras in the park to help police monitor nepharious activities, ensure safety to park visitors, and ensure responsible parties are held accountable for any damages.

The grass area continues to experience dog defecation, even though bags and a pick up stations are in place. All park participants are required to use the park with consideration of others and pick up after your pets.
