**A RESOLUTION OF THE LEEDS TOWN COUNCIL TO
OPEN AND AMEND THE 2021-2022 BUDGETS FOR
THE GENERAL FUND AND THE CAPITAL
IMPROVEMENT FUND FOR THE TOWN OF LEEDS,
UTAH**

WHEREAS, the Town Council of the Town of Leeds, Utah, held an open and public hearing on the 8th day of December 2021, to review the 2021-2022 budgets for the Town of Leeds; and

WHEREAS, after public comment, the Town Council of the Town of Leeds, Utah, reviewed and approved the amended 2021-2022 General Fund budget to reflect an increase in the allocation from accumulated surplus and an increase in employee benefit expenditures of \$146,471.89; and

WHEREAS, after public comment, the Town Council of the Town of Leeds, Utah, reviewed and approved the amended 2021-2022 Capital Improvement Fund budget to reflect a transfer from the General Fund accumulated surplus in the amount needed to bring it into compliance with the accumulated fund surplus limitation as calculated by the Town of Leeds auditor;

NOW, THEREFORE, BE IT RESOLVED BY THE TOWN COUNCIL OF THE TOWN OF LEEDS, UTAH, that, at a regular meeting duly called, noticed and held on December 8, 2021 upon motion made and seconded, and by roll call vote, for the amended budgets for the fiscal year 2021-2022, attached hereto as Exhibit "A", including all schedules thereto once provided by the Town of Leeds auditor, is hereby adopted, subject to later amendment as provided by Utah law.
